This letter is written confirmation that Flex Membrane International Corp., the manufacturer of Flex Thermoplastic Single Ply and Multi-Ply Roofing Systems, has a contractor acceptance policy that provides for the issuance of a roof warranty to commercial roof contractors who have exhibited financial and installation ability required to install Flex's Roofing Systems. Flex Membrane International Corp. welcomes **Detwiler Roofing, LLC of East Earl, PA** as an authorized and approved applicator of Flex Roofing Systems.

Flex Roofing Systems are installed in the manner of standard thermoplastic roof assemblies which follow the National Roofing Contractors Association guidelines for thermoplastic installation and flashing details. Flex through direct and agency representation, provides start-up assistance and periodic instruction and inspection service to insure that the contractor is given sufficient direction and hands on expertise to successfully complete his contract. The contractor must coordinate the project start-up with Flex's Technical Service Department at least ten (10) business days prior to the beginning of the Flex Roofing System Application. It should be noted that acceptance of the deck's surface and structural integrity are the responsibility of the roofing contractor. Flex provides the Contractor with a Request for Flex Guarantee form, which must be received by Flex Technical Services prior to project start-up. If this document is not received by start date, a Material Only Warranty will be applicable. Provided that all installation details have been completed to the specifier's requirements and in accordance with Flex's current specifications and details, whichever is more stringent, a warranty will be issued.

Flex Membrane International Corp. would like to formally thank you for your interest in Flex Thermoplastic Roofing Systems. Based on this approval, it is anticipated that the contractor will support and promote Flex products. Failure to do so will result in discontinuance of your approval status. Also, upon 6 months of inactivity or in the event of poor workmanship the effect of this approval will expire. Please feel secure in the knowledge that Flex and our representative will give our best effort to see that the installation is completed in the most efficient and secure method.
